**IMMEDIATE RESTRAINING ORDER (Ex Parte)
AND HEARING NOTICE**

1. **This Order starts immediately and ends after the hearing listed below.**
2. **Hearing Notice** – The court will consider extending this order and the other requests made by the protected person at a court hearing:

on: Tuesday, December 17th, 2019 at: 9:00 a.m.

at: King County Superior Court, 516 3rd Ave, Seattle, WA 98104, as assigned

Warning! If you do not go to the hearing, the court may make orders against you without hearing your side.

3. **This Order restrains (name): Michael DeLance**

Warning! You must obey this order or you may be jailed.

- Violation [of sections 6-8] of this order with actual notice of its terms is a criminal offense under Chapter 26.50 RCW and will subject a violator to arrest.
- Violation of **any** part of this order may result in financial penalties or contempt of court.
- This order is enforceable in all 50 U.S. states, the District of Columbia, and U.S. territories and tribal lands (*18 U.S.C. § 2265*).

7 **5. Findings**

8 The court has reviewed the *Motion for Immediate Restraining Order*, supporting
9 documents, and any other evidence considered on the record, including the Declaration
10 of Sonya DeLance, the Declaration of Joanna McGuire, the Declaration of Jason
11 Lander, and other pleadings on file in this matter. The court finds that there would be
12 irreparable harm as described in the *Motion* if this order is not granted.

13 [] *If hearing date is more than 14 days away* – There is good cause to keep this order
14 in effect until the hearing date (which is between 14 and 28 days after this order is
15 issued) because (*describe the good cause*):

16 Michael DeLance is ordered to take a Urinalysis Test with ETG and 10-panel hair
17 follicle or toenail test within 4 hours of notice of entry of this Order. Pending the
18 hearing, Michael DeLance's residential time is suspended. Michael DeLance is
19 prohibited from communicating with Sonya DeLance and with the children named
20 in Section 4 above via e-mail, text message, phone call, our family wizard, or by
21 any other method of written or oral communication, whether directly or indirectly.

22 ➤ **Court Orders to the Restrained Person listed in 3:**

23 **6. Do not disturb**

24 [X] The Restrained Person must not disturb the peace of the Protected Person or of any
25 child listed in 4.

26 **7. Stay away**

[X] The Restrained Person must not go onto the grounds of or enter the Protected
Person's home, workplace, or school, and the daycare or school of any child listed in
4.

[X] The Restrained Person must not knowingly go or stay within 300 feet of the
Protected Person's home, workplace, or school, or the daycare or school of any child
listed in 4.

1 **8. Do not hurt or threaten**

2 [x] The Restrained Person must not:

- 3 ▪ Assault, harass, stalk, or molest the Protected Person or any child listed in 4;
or
- 4 ▪ Use, try to use, or threaten to use physical force against the Protected Person
5 or children that would reasonably be expected to cause bodily injury.

6 **9. Surrender weapons**

7 [X] Does not apply. No order entered in section 8 and no request made.

8 **10. Care and safety of children until the hearing**

9 [X] The Respondent must not take the children listed in 4 out of Washington state.

10 [X] Until the hearing, the children listed in 4 will live with the *Mother/Petitioner*.
Michael DeLance’s residential time shall be suspended until further Court order.

11 [X] Michael shall deliver the children to King’s Kid’s Club (KKC) at the children’s
12 school by 5:30pm on December 3rd; however, if the order is served after KKC has
13 closed, then Michael shall return the children to the parking lot of the Edmonds
14 Police Department within one hour of service of the Order. Michael shall provide
one single e-mail through Our Family Wizard to notify Sonya of when and where the
children will be delivered if the exchange takes place in the parking lot of the
Edmonds Police Department, both parties shall stay in their vehicles and the children
shall walk from one vehicle to the other.

15 **11. Protect property**

16 [X] Does not apply.

17 **12. Do not change insurance**

18 [X] Does not apply.

19 **13. Bond**

20 [X] Does not apply.

21 **14. Other immediate orders**

22 [X] Michael DeLance is ordered to take a UA with ETG test and a 10-panel hair
23 follicle or toenail test within 4 hours of notice of entry of this order.

24 [X] Michael DeLance is prohibited from communicating with Sonya DeLance and
25 with the minor children named in Section 4 above via e-mail, text message, phone
26 call, our family wizard, and/or by any other method of written or oral
communication whether directly or indirectly.

2 Seattle Police Department shall serve this Order.

15 **Warning! You must have this order served on the Restrained Person before it can be enforced.**

16 **You have a right to have law enforcement serve this order free of charge if restraints are ordered in sections 6, 7, 8, or 9 above.**

- 17 1. Fill out a *Law Enforcement Information Sheet* (form All Cases 01.0400) and give it to the clerk.
18 2. You must have this Order, and the paperwork you filed with the court to get this Order, personally served on the Restrained Person by someone 18 or older who is not a party to this case. (Do not serve the *Law Enforcement Information Sheet* on the Restrained person – it is only for law enforcement.)
19 3. After serving, the server fills out a *Proof of Personal Service* (FL All Family 101) and gives it to you. Then:

 - 23 ■ Go to the hearing.
 - 24 ■ Bring proposed orders to the hearing.
