**DECLARATION OF JASON
LANDER IN SUPPORT OF EX
PARTE MOTION**

I, Jason Lander, am not a party to this action. I am competent to testify as a witness and I make the following statements based on my personal knowledge of the facts and circumstances stated below.

1. I am the partner of Sonya K. DeLance, Petitioner in the above referenced matter. I have been dating Sonya for more than eight months and I have known Sonya and her family for years.

2. Respondent, Michael DeLance, has made it well know he does not care for me. He tells Sonya and me often, using vile language and threats. I have watched as Sonya attempts to navigate his various moods and tried to support her attempts to co-parent with him despite his terrible language and manipulative behaviors. Recently, his behavior escalated out of control while he had Presley (10) and Ella (8) in California for the Thanksgiving holiday.

ORIGINAL

1 3. Late in the evening on Saturday, November 30, 2019, I noted new comments
2 made by Michael on photographs I previously posted on Facebook. Among those comments
3 included a veiled threat in reference to a photograph of me near a nice car, “**and you’re lucky**
4 **yours not under the tire...**”. True and correct copies of those recent comments from Michael
5 are attached as **Exhibit A**.

6
7 4. In light of the public threat, I responded to Michael directly via Google Voice
8 Messaging. But the barrage that followed, including videos of him with the children, were
9 sickening. A true and correct copy of our direct communication on Sunday, December 1,
10 2019 is attached as **Exhibit B**. Michael closes the direct discussion at **8:06 pm** with the
11 following: “**I’ve shown my children these messages... You’re the good guy...**” “**Actually**
12 **lets FaceTime now**”. Ex. B, pg. 3.

13 5. Then, Michael began using a Group Text with myself and Sonya. A true and
14 correct copy of the Group Text is attached as **Exhibit C**. Using Group Text, he sent us the
15 first **video message at 8:09 p.m.** and a second **video message at 9:17 p.m.** Those video
16 messages are transcribed by Sonya in her declaration. Both children are present in the video
17 messages. I have reviewed both of the video messages and Sonya’s transcription and found
18 Sonya’s transcription to be an accurate reflection of the vile things said by Michael in front of
19 the children.

20
21 6. Using the Group Text Feature, Michael then felt compelled to FaceTime call
22 both Sonya and me—apparently after a well check visit from the police. The Sonya recalled
23 in detail the conversation in her declaration. I was present for the call, reviewed Sonya’s
24 description, and agree her description is an accurate reflection of statements by Michael,
25

1 Sonya, and the children. Both Sonya and I begged Michael to stop this behavior in the
2 children's presence. He refused.

3 7. On Sunday, December 1, 2019, I had a missed call from Sonya's son, Presley.
4 I responded to the missed call with text messages to Presley but received no response from
5 him. Today, on December 2, 2019, I received a response from Michael on Presley's phone.
6 A true and correct copy of those messages are attached as **Exhibit D**.
7

8 8. Michael demands I stay away from him (no problem) and Sonya's children.
9 Michael cannot stand the thought of Sonya happy with anyone else and will do whatever he
10 can to sabotage her. He is using the children as a sword to punish Sonya and sees zero
11 disfunction in his behavior. The confusion and fear in the children is evident on their faces.
12 The Court has to intervene; he will not stop.

13 *I declare under penalty of perjury, under the laws of the State of Washington, that the*
14 *foregoing is true and correct.*

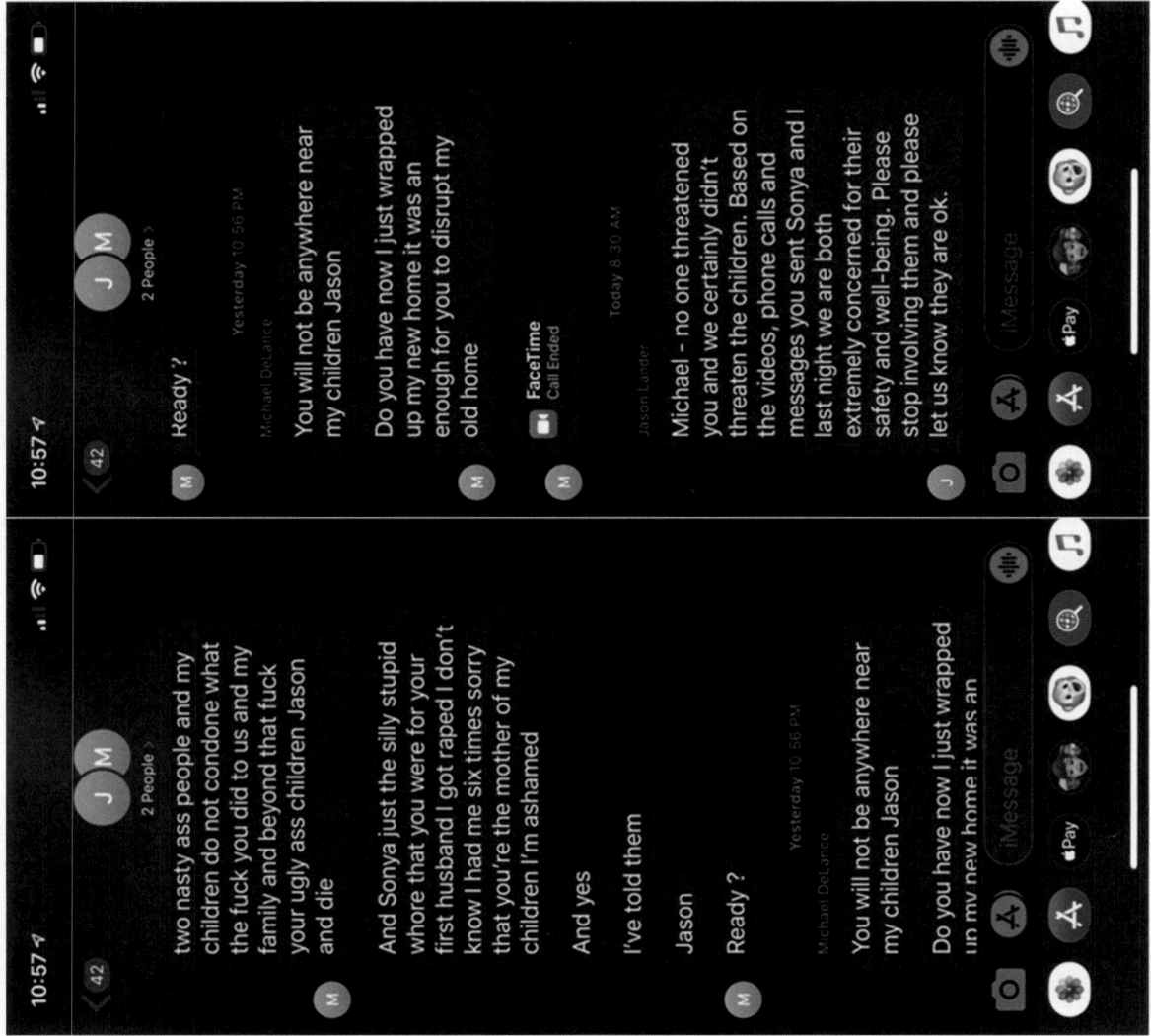
