ORDER 16 THIS MATTER came before the Court on review of a Contempt Order entered against 17 the Respondent on August 20, 2020 and a Return Hearing on November 4, 2020. The Court 18 considered all pleadings filed in this matter and heard oral argument from counsel and the Court 19 being otherwise fully advised; it is now: 20 ORDERED, ADJUDGED, AND DECREED that: 21 Michael DeLance failed to purge contempt as he did not remain in strict 1.1 22 compliance with the Temporary Parenting Plan. The Court is concerned about 23 Michael DeLance's actions following entry of the Contempt Order. Due to 24 Michael DeLance's failure to strictly comply with the Temporary parenting plan, 25 a Temporary Restraining Order shall enter contemporaneously with this Order. 26 The Temporary Restraining Order does not discontinue visitation, which shall ORDER ON CONTEMPT REVIEW HEARING -BERESFORD • BOOTH, PLLC

- continue to follow the terms of the Temporary Parenting Plan and recommendations from the parenting coordinator
- 1.2 Michael DeLance failed to purge contempt as the Land Rover debt. The Court does not have authority to require that Michael DeLance pay the Land Rover in full. Michael DeLance shall make the equivalent of two Land Rover payments no later than November 6<sup>th</sup>. These payments shall be for the November and December 2020 payments. Payment shall be made directly to the lender and proof of this payment shall be provided to Petitioner's counsel. Regular automatic monthly payments shall begin on December 6, 2020. Michael DeLance must timely pay all future Land Rover payments.
- 1.3 Michael DeLance failed to timely pay the spousal maintenance arrearage of \$148,338.68, which was due on October 5, 2020. Michael DeLance paid \$25,000 toward this judgment on October 3, 2020, and the remaining \$123,338.68 on October 6, 2020. Though he did not timely pay this debt, the Court is finding that this judgment has been paid in full.
- 1.4 Michael DeLance is hereby ordered to pay \$16,899 to Sonya DeLance for attorney's fees and costs incurred in this action. Michael DeLance may pay this in three installments, but it must be paid in full no later than January 6, 2021. Payments shall be made directly to Sonya DeLance. If not paid in full by January 6, 2021, then Sonya DeLance may enter a Judgment ex parte at that time without the need for a hearing, at which time 12% statutory interest accrue.
- 1.5 Michael DeLance timely paid the past-due children's expenses, the OFW Annual Fee, and the civil penalty, and contempt is purged solely with respect to those judgment amounts. Contempt is purged with respect to these judgments.
- 1.6 Michael DeLance shall provide documentation from his CPA regarding the status of the 2017, 2018 and 2019 Tax Returns. This documentation shall be produced to
