
2. Supervision will be provided by At Indaba. Michael is responsible to schedule the supervised visit and to pay the expense.

3. Sonya will deliver the children to a location designated by the Supervisor prior to the visitation commencing.


4. The Visitation Supervisor will provide a written report/summary of the supervised visit to each parent via his/her attorney of record.




