[x] Other: Michael DeLance submitted a \$75,000 payment to Ms. Delance on April 21, 2021. That payment has been allocated as follows:

- 1) \$295 in attorney's fees ordered at the June 1<sup>st</sup> hearing
- 2) \$2,638.84 as reimbursement for payments of Michael court-ordered obligations;
- 3) \$712.16 as reimbursement for the children's expenses; and
- 4) \$1,411.12 representing \$1,386.50 in principal and \$24.62 in interest to 4/21/2021 owed for attorney's fees from the Court's February 26, 2021 Order Re: Reinstatement of Health Insurance
- 5) \$484.16 representing \$472.51 in principal and \$11.65 in interest from 2/5/2021 to 4/21/2021 owed for attorney's fees from the Court's Order on Contempt Review.
- 6) \$39,588 in principal owed on attorney's fees from the Court's Final Order and Findings entered on February 23, 2021.

With entry of this order, the above judgments will have been satisfied and deemed paid in full.

The total amount allocated to the four existing judgments is \$45,129.38 which shall be deducted from the \$75,000 payment received by Ms. DeLance on April 21, 2021. The remaining \$29,870.62 shall be credited toward the outstanding spousal maintenance due.

As \$120,000 was due from Mr. DeLance to Sonya DeLance on April 15, 2021, after applying the \$29,870.62 credit, **\$90,129.38** is due and owing for spousal maintenance from April 15, 2021 to June 15, 2021. Judgment for past due spousal maintenance shall enter in that amount and is represented in the table in Section 8.

2. The court has considered the *Motion for Contempt Hearing* and any supporting documents, response from the other party, reply, and other documents from the court record identified by the court. A contempt hearing was held on **June 15, 2021**.

6 **13. Other orders (if any)**

7 (1) All uninsured health care costs incurred for the children shall be paid in full by Michael DeLance  
8 and shall not count against the \$10,000 limit as described in Section 19 of the Final Child Support  
9 Order.

9 (2) Michael DeLance shall immediately pay the bill due and owing to North Seattle Pediatrics in the  
10 amount of \$899.76. Mr. DeLance shall provide proof of the children’s insurance through the  
11 communication coordinator on the 1<sup>st</sup> of every month.

11 (3) If Michael DeLance cancels or causes the children’s’ health insurance to lapse again, Sonya  
12 DeLance may file another Contempt Motion and request that the Court order jail time in addition to  
13 having to reinstate the insurance and pay her attorney’s fees and costs for having to do so.

13 (4) Michael DeLance shall pay the Land Rover debt in full within thirty days of this Order.  
14 Alternatively, Sonya DeLance may pay the balance in full and shall be entitled to a judgment against  
15 Michael DeLance equal to the payoff amount accruing interest at the rate of 12% from the date of the  
16 payoff until the judgment is paid in full. If Sonya DeLance pays this debt, she may enter an Ex Parte  
17 Judgment for the amount paid by her accruing 12% interest from the date payment is made.

15 (5) Michael DeLance shall provide proof of the post-secondary accounts as required per the Decree  
16 within 14 days of entry of this order.
