ORDER APPOINTING SPECIAL MASTER AND OTHER RELIEF

THIS MATTER came on before the undersigned Commissioner of the above-entitled court on Petitioner's Ex Parte Motion to Appoint a Special Master and Other Relief following entry of Order Enforcing the Parties' CR2A Agreement entered with the Court on February 15, 2022. The Order Enforcing the Parties' CR2A Agreement directed the Respondent to sign necessary property transfer documents no later than February 17, 2021. The Respondent has failed to do so. Having considered the pleadings, and good cause appearing, the court hereby ORDERS:

- 1. <u>Appointment of Special Master</u>. Attorney Richard D. Wurdeman is appointed as the Special Master in this case, and he is vested with the following authority:
  - a. On behalf of the Respondent, to execute any and all documents necessary to effectuate the transfer the Tarukino/SoRSETech shares to the Petitioner as required by the Decree of Dissolution and CR2A Agreement executed on November 26, 2021. Specifically, to sign any and all documentation

required to transfer 343,403 shares of the Series Seed Preferred Stock and to transfer 1,310,243 shares of the Common Stock from the Respondent to the Petitioner.

- b. To decide any and all issues presented to him by the parties relating to the transfer of the Tarukino/SoRSETech shares.
- c. To issue such orders as he, in his sole discretion, deems necessary to effect the transfer of the Tarukino/SoRSETech shares. Any such orders made by the Special Master shall be final, without right of appeal, as between parties.
- d. On behalf of the Respondent, to communicate by any means necessary with the company regarding the documents necessary to effectuate the transfer of the Tarukino/SoRSETech shares.
- e. On behalf of the Respondent, to execute a Consent form and any other documents necessary to allow the minor children to travel domestically or internationally with the Petitioner.
- f. To decide any and all issues presented to him by the parties relating to the Petitioner's travel with the minor children.
- g. To issue such orders as he, in his sole discretion, deems necessary to effect the Petitioner's travel with the minor children.
- 2. <u>Payment of Special Master</u>. The fees and costs charged by the Special Master under this appointment shall be borne by the Respondent, Michael DeLance. Any such fees paid by the Petitioner shall be entered as a judgment in her favor against the Respondent and may be entered and an Ex Parte judgment.
