**I. Relief Requested**

**II. Statement of Facts/Statement of Grounds**

The Order Appointing Special Master and Other Relief was entered by default on 3/28/22. The default was obtained because of three events. First, we had entered into a CR2A agreement. Second, the petitioner's attorney drafted up agreed documents to enforce the CR2A, but I did not agree with the content that was outside the scope of the CR2A agreement. Primarily, there were many insertions into the Parenting Plan that did not exist in the current parenting plan or the CR2A. After many email exchanges,
